MNCH2 Monthly Flash Report February 2019

KATSINA

Katsina State is in the Sahel Savannah in northwest Nigeria. It has a total population of nearly 6 million. Each ward has at least one functional primary health facility and the state has seen great improvements in some health indicators: delivery by skill birth attendance has risen from 5.1% in 2008 to 20.8% in 2017. However, antenatal attendance stands at 33.40% and immunisation coverage is 6%. The unmet need for child spacing is 29.5% (MICs 2016/2017).

Key achievements

- Rapid assessment of storage facilities were conducted in 12 selected medical stores across the state. The assessment aimed at reviewing compliance to good storage practices, identifying challenges to storage and distribution of essential medicines and other medical consumables.
- The programme provided technical support to the State Ministry of Health (SMoH) in the development of Family Planning Costed Implementation Plan for the year 2019.
- MNCH2 supported the State Primary Health care Agency (SPHCA) in domesticating and costing of Minimum Service Package which also complements the requirement for accessing Basic Health care Provision Fund (BHCPF)
- The programme provided technical support in the development of healthcare budget scorecard. The scorecard is a very useful tool for advocacy for increased funding and release to the health sector of the state.

- Follow up meeting with Safe Space Initiative (SSI) and Emergency Transport Scheme (ETS) data for the guarterly report
